## Walk-in Behavioral Health Urgent Care Now Open

Cherry Health recently opened the Behavioral Health Access Center & Urgent Care within our Heart of the City Health Center in downtown Grand Rapids. This walk-in space is the first point of contact for those with urgent mental health needs and, for many, is the first step toward healing. When someone is feeling depressed and overwhelmed, they need a professional who can meet them where they are and help support them on their journey. And they need that connection right away.

Upon entry, individuals meet with a Behavioral Health Clinician and a Community Health Worker. Evaluations are performed to identify their mental health needs as well as schedule referrals for other Cherry Health services and community resources. Cherry Health's seamless approach to caring for the whole person and offering hope and healing is exemplified by Lewis and his son Jakob, who came to the Access Center on the recommendation of a friend.

Jakob previously suffered a Traumatic Brain Injury (TBI) in a car accident. He came to the Access Center angry. Lewis had spent the last year seeking help for his son elsewhere and faced a stream of unreturned phone calls

and appointments scheduled too far into the future. He was feeling hopeless. Jakob needed help now.

On their first visit to the Access Center, Jakob met with a Behavioral Health Clinician who evaluated his mental health needs, then scheduled an appointment as well as referrals to other Cherry Health services. For Jakob, this included a primary care provider and dental and physical therapy appointments. The Community Health Worker connected Jakob to resources and, together, they made plans to address his addiction and housing needs.

When Jakob left the Access Center, he broke down in tears in the elevator. For the first time, he felt seen, heard, and hopeful that he was beginning his path to healing.

# See What Your Gifts Have Done

Spunky 7-year-old Catilaya entered Cherry Health’s Heart of the City Health Center bursting with life and joy. With her came an unfilled, substantial corrective vision prescription. Through our partnership with the Grand Rapids Lions Club to help provide eye exams, glasses, and other vision-related services to underserved populations, Optician Derrick Coombs helped Catilaya find the perfect frames. They fit her bubbly personality as she danced and spun in circles.

Despite her extreme nearsightedness and low vision, Catilaya clearly saw so much beauty in the world. Derrick was thrilled that Cherry Health was able to give her a pair of glasses she loved wearing so that she will be able to experience even more of what the world has to offer.

Additionally, Cherry Health offers Teleretinal imaging, having purchased retinal cameras for five of our medical centers. This non-invasive screening process uses a special camera to examine the back of the eye. This camera is often used for early detection of diabetic retinopathy and other eye conditions such as glaucoma, macular degeneration, and retinal detachment. It can even detect high blood pressure and some forms of cancer. Being able to perform this screening within the medical center eliminates the need for patients to schedule a separate vision appointment. Early detection can be the key to successful treatment, management of chronic conditions, and even lifesaving intervention.

Last year, our vision-based clinicians saw patients during 12,337 appointments, treated 2,307 students at their schools, and dispensed 10,253 pairs of glasses.



# What is a Federally Qualified Health Center?

You have often heard Cherry Health referred to as a **Federally Qualified Health Center (FQHC)**, but what does that actually mean? **Cherry Health is a community-based healthcare organization that provides comprehensive primary care and support services to underserved populations.**



**Currently, FQHCs, including Cherry Health, have concerns due to proposed cuts to Medicaid funding. Approximately 49% of Cherry Health's nearly 58,000 patients are Medicaid recipients. Medicaid is a vital source of care for these individuals and, therefore, an important source of funding for FQHCs. If Cherry Health patients were to lose their Medicaid coverage, the number of uninsured patients, and thereby unreimbursed care costs, would increase greatly.**
